- Entrance for the house is an issue, cannot move entrance because of underground drainage issue
- Proxy is permission to sell not how to sell.
- If we want to sell in two parcels we need to get Andy Buck to complete survey and split it.
- Concern is selling property without having the funds to create new parking lot in the meantime.
- Concern with splitting the proceeds among the parishes.
- Possibly ask for a lease for 5 years from buyer until our new parking lot is done.
- Removal of trees to create a new parking lot and work on bell tower parking lot would be safer and more cost effective.

 one.
